

Terms & Conditions of MotorMax or MotorMax *Plus* Motor Insurance (“Promotion”)

1. This Promotion is organised by MSIG Insurance (Singapore) Pte. Ltd. (“MSIG”).
2. Promotion Period (“Promotional Period”): 12 November 2021 to 19 December 2021, both dates inclusive.
